2. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Bidders are bound to accept the orders accordingly.

1. Technology to be used: Next Seq Platform (Attach installation Certificate)
2. Application: Small RNA Sequencing
3. Sample Type: Total RNA will be provided to the vendor

4. No of sample: 16
5. Vendor Should QC the sample to ensure optimal concentrations and purity.
 - Qubit 1ug/20ul low TE buffer
 - 260/280 Ratio: Above 2.0 and 260/230 Ratio: Above 1.0

Quality control should be done using Bioanalyzer and Small RNA assay. Report of the same should be provided.

Library Type: Small RNA library compatible for Illumina sequencing to be prepared using standard kits and methods.

6. Library QC using Qubit, Tape station and qPCR to be used for measuring the quality and quantity of the library before sequencing. Report on the same should be provided. Read Length and Data: **75X1/ 50 SE to generate between 15 and 18 million single end reads per sample.**
7. At least **>90%** of the data should be **>Q30** quality.
8. **No Bioinformatics analysis required.**
9. **The company should have good experience/ record in conducting above mentioned experiments before with proof of publications, purchase order and satisfaction certificate given in writing.**
10. **Vendor should have in-house sequencing facility in India and Illumina certified vendor and certification will be considered more competent than others without certifications.**
11. **Samples (Tissue, DNA or RNA etc.) should not be sent out of India.**
12. **Minimum 50 Small RNA Sequencing work orders from recognised government institutes (any ICMR institutes are preferable) should be attached along with quotation.**
13. **Proof of Publications: Minimum 100+ publications should be cited for NGS and Analysis**
14. Proof of lab facility: **Illumina NextSeq installation certificate in India should be provided**, partner/collaborator company installation certificate located abroad will not be considered.
15. Quotation should be on firm's letter head with **GST Number, PAN Number and CST Number** mentioned clearly.
16. **Establishment of firm: Firm should be established in India minimum 6 years before with NGS lab and experience in handling NGS projects and successful completion (Testimonial should be provided). Please provide establishment of firm certificate along with tender docs.**
17. Data should be delivered through **secured server & HDD only**. To maintain data confidentiality, firm should not write data in CDs/DVDs.
18. Time lines to complete the project should be written clearly and should not exceed more than 6 weeks.
19. The details of progress of experiment will be intimated to the customer/scientist and further processing in case of any issues will be based on the instructions of the customer only.

20. MSME certificate for Scientific research and development should be attached along with quotation (preference will be given to MSME, as per Government rules)

21. Failure to submit quotation as per the technical specification may deprive the concerned firm from consideration.

22. The vendor should take responsibility to ship the sample from institute.
