1. The bidder shall submit all required documents in a proper sequence and arranged format as per the tender requirements. If the documents are not submitted in the prescribed sequence or format, the bidder shall be treated as disqualified in nature. The Buyer shall not be bound to respond or entertain such type of bidders.
2. The bidder should have to accept and agree with the all term and condition which is mentioned in the bid documents .
- 3.The Bidder should have to own valid in-house housekeeping and pest control licenses (ISSUED BY BIHAR GOVT.).
4. .The Bidder should have to submit the Similar type of work experience in any ICMR institute.
5. .The Bidder should have to submit Appreciation letter from the existing clients.
6. The Bidder should have to submit GeM Star Rating or Award certificate from any research center, hospital, or institute under the Government of India.
7. The Bidder should have to submit Currently running projects in consignee location (Bihar).
8. The Bidder should have to submit Experience in years for Housekeeping Manpower supply.
- 9.The Bidder should have to submit Self-Attested copy of CA certificate with last three-year balance sheet, Income Tax Returns. CA certified copy.

10. The bidder must have an Annual Turnover of not less than of Rs. 03Cr. during the last three consecutive financial years. Chartered Accountant certified copies of Profit & Loss account, audited accounts/ balance sheet and IT Return and IT clearance certificate also to be attached.

11. The bidder should possess ISO 9001:2015 or latest updated version of the certification in providing Manpower services and the certificates should be enclosed along with the bid.

12. The bidder should have valid registration from the concerned authorities for Services & Taxes (proof to be enclosed).

13. To submit the copy of PAN,TAN,ESI,PF and GST Registration.

14. A company, firm or agency should be registered with/ have requested required business License and should be valid at least three months as on date of opening of bids.

15. The firm should not have been black-listed by any Central Govt./ State Govt./ Govt. PSUs/ Undertaking/ Organizations or allies 'agencies. No Vigilance/ CBI case should be pending against the bidder. A certificate to be given to this effect on own letterhead.

16. The bidder shall submit a declaration certificate stating that the company has never been declared bankrupt, insolvent, or blacklisted by any Government Department, PSU, or statutory authority.

17. The Bidder have to submit the PERFORMANCE BANK GUARANTEE & Bid Security Declaration.

18. The bidder shall submit proof of age and character certificates for all employees at the time of their deployment in the institute.

The cost of such consumables, machinery, cleaning agents, and equipment may be claimed in the monthly bills as per actual requirement and approval

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
